ix) To invest the funds of, or money entrusted to, the Trust upon such securities or in such manner as may from time to time be determined by the Trustees and limited to those investments recognized under Tax Laws for the purpose of Income Tax exemption and from time to time, to

3- The Trustees of the Trust including the original Trustees nominated by the Chairman (Settler) shall remain for a period of three years from the date of appointment, but they may retire voluntarily and shall hold the office during the pleasure of Settler/Chairman. In case of resignation, removal, death, disqualification or otherwise the Settler/Successor may appoint trustee in his/her place for the remainder of the term. There shall be no trustee and not less than two excluding Settler. The Settler shall remain Chairman for life and he shall have the right to nominate his successors, or in the absence of which this office shall go to his legal successors.

4- The Trustees shall hold and stand possessed for the Trust money and property and all other investments of any kind into which the same or any part thereof may be converted, investments of any kind into which the same or any part thereof may be converted, invested, or varied from time to time and all accumulations thereof upon the Trust and subject to the powers and provisions hereinafter contained of and concerning the same, and shall apply the income thereof, and if the income is insufficient shall apply the corpus thereof or so much of the income of the corpus as may be necessary in the opinion of the Trustees for the attainment of the objects of the Trust.

 - ii) To grant scholarships and fellowships and research or travel grants to poor and deserving students for the purpose of undertaking prosecuting and promoting study and research work in humanities, social science and natural sciences including chemistry, physics, electric therapy, radiology and bacteriology, medical and/or surgical science or agricultural science or and other branch or branches of modern applied science in its widest and most comprehensive sense
 - iii) To set up or help by endowment or donations orphanages and/or poor houses for the benefit of orphans and poor persons or otherwise helping the poor and the needy persons in indigent circumstances.
 - iv) To construct and maintain reading rooms, community halls, dharamshalas, public rest houses, public ghats, place of worship, old age houses and public wells and to feed the poor and named persons.
 - v) Generally on such other objects of charity and public good as the trustees may think proper, provided they are covered by the definition of "Charitable purposes" as per section 2(15) of the Income Tax Act, 1961 with all the statutory modifications and replacements thereof in future.

xxviii) For the purpose of the Trust to draw, accept, make endorse, discount and negotiable Government of India and other promissory notes, bills of exchange, cheques or other negotiable instruments.

xxix) To borrow and raise money with or without security or on the security of a mortgage, charge or on the security of hypothecation or sell, transfer or dispose of such investments.

xxx) To work for nation building through education.

xxxi) To undertake any work related to the academic field.

xxxii) To sell, assign, mortgage, lease, license, exchange or otherwise transfer or dispose of all or any property, movable or immovable of the Trust for the furtherance of the objects of the Trust.

xxxiii) To appoint or employ, temporarily or permanently, any person or persons and to pay them or other deputed or seconded persons for services rendered to the Trust such salaries, wages, gratuities, provident funds and pensions, and to introduce and implement welfare scheme including, but not limited to superannuation, housing scheme for benefit of such persons as the Trust may, on its behalf, determine and.

xxxiv) To promote democracy by means of financial help or otherwise to the candidates including Settler/Trustees contesting or likely contest democratic organizations.

xxxv) To do all such other lawful things as the Trust may consider necessary, expedient incidental or conducive to the attainment of the above objects.

xxxvi) To profess, practice, promote and propagate Hindu Religion.

xxxvii) To establish and maintain religious place/s of worship including institution.

xxxviii) To establish, construct, reconstruct, maintain Temple or place of worship.

xxxix) To an anger religious conference, celebrations, kirtan, debates, competition etc.

xxxx) To conduct other work relating charitable pious and religious purposes.

6- Office Bearers



The Board of Trustees shall have the following office bearers who will be nominated by the Settler amongst the Trustees for the period of five year from the date of appointment.

- a) Chairman
- b) Vice-Chairman
- c) Secretary
- d) Treasurer

a) Chairman:- Smt. Manju Singh the Settler shall hold the office of Chairman on Trust till his death. Settler/Chairman may nominate his successor effective during his life time or after death. The successor so nominated shall have all powers and privilege of settler or the Trust as provided in the Trust Deed.

Every meeting of the Board of Trustees shall be presided over by the Chairman and in his absence by the Vice-Chairman. The Chairman has veto power against any resolution or action of the Trust.

b) Vice Chairman:- When the Chairman is unable to discharge his functions owing to absence, illness or any other cause, the Vice-Chairman shall discharge his functions until the date on which the Chairman resumes his duties. The Chairman may assign any duty to Vice Chairman.

c) Secretary:- The Secretary may delegate and/or sub-delegate such of the powers as he may consider necessary to other trustees or officials of the Trust with the prior approval of Chairman/Settler. The Secretary shall be responsible for the maintenance of all records of the Trust, including agenda, minutes of the proceedings of the Board of Trust and compliance of other statutory requirements. He/She shall perform such other functions as may be assigned by the Board of Trustees/Chairman.

d) Treasurer:- The Treasurer shall be in charge of cash and accounts and shall work in co-operation and consultation of Board of Trustees/Chairman.

7- That no member of the Trust shall be entitled for payments out of the funds of the Trust. All trustees shall work in a honorary capacity. But some payment shall be admissible to a Trustee for meeting conveyance charges and incidental expenses incurred in discharge of duties assigned by the Board of Trust. Provided that nothing herein contained shall prevent the payment in good faith of remuneration to any Trustee thereof or other person in return for any service rendered to the trust in professional capacity.

8- That all meetings of the Trust shall be presided over by the Chairman. The agenda of the meeting shall be circulated by the Secretary at least 7 days in advance in consultation with the Chairman. In a very special situation, meeting may be called by the Chairman at a Shorter notice. All decisions shall be taken by a majority of votes. In the event of a tie, the Chairman presence of at least 3 members, including the Chairman shall constitute the quorum.

9- That without prejudice to generality of the powers in the management and execution of the trust, the Trustees may employ officers, servants, solicitor, councils, auditors, experts, advisers brokers, bankers and the like for the proper administration of the affairs of the Trust upon terms and conditions as they think fit, and in such a case the Trustees may delegate some of their powers to those dealing with the affairs of the Trust in this regard.

10- The Trustees, for the time being as well as whom so convenient, shall frame as cause to the framed rules and regulations for the management and administration of the affairs of the Trust by 2/3 majority of the members, present and voting. In order to meet some exceptional situation, the Chairman shall have power to issue rules and regulations subject to their approval by the Board of Trustees from time to time. These rules and regulations shall be in conformity with the laws of the country in force.

11- That the Trust shall hold its meeting at least once a year, though a special or emergent meeting may be summoned by the Chairman whenever necessary.

12- The accounting year of the Trust shall be the financial year ending on 31st March every year.

13- That the Board of Trustees shall have the power to work in association with some other similar public charitable institution for the fulfilment of its declared objects. The Board of Trustees shall also have the power to affiliate. The Trust with such Institution or merge it with the same.

14- If any doubt arises as to the meaning or interpretation of any word or clause of the constitution of this Trust or its execution, the decision of the chairman of Board of Trustees shall be final and binding.

15- A Trustee shall hold his office for five years, his office shall be vacated if-

- i) He tenders his resignation from such office in writing, or
- ii) He is adjudged as an insolvent, or
- iii) He is found to be of unsound mind by a court of competent jurisdiction,

or

iv) He is found guilty of an offence involving moral fortitude by a competent court, or

v) He acts in any manner prejudicial to the interests of the trust or is otherwise guilty of breach of

vi) He is asked in writing to resign unanimously by the remaining Trustees.

vii) He has been removed by the Settler/Successor.

16- Modification in any clause of this Trust may be made, subject to its adoption in a meeting called for the purpose with 10 clear days notice, and passed by three fourth of majority of the total number of Trustees present in person or by proxy, provided that no modification shall be made so as to change the charitable nature of the Trust.

17- The Board of Trustees may make such rules, regulations or bye laws as may be necessary for carrying out the purpose of the Trust.

18- It shall be lawful for the trustees to amalgamate the Trust with any other Trust for totally public Charitable purposes and whose objects are the same or similar to all or any of the objects of this Trust.

19- Powers and Functions of the Trust

a) All property, both movable and immovable, shall be vested in the Board of the Trustees.

b) The management of the business and affairs of the Trust shall be vested in the Board of Trustees which shall exercise all such powers and authority of the TRUST as are not specifically and expressly vested by these Rules or by statute, and are required to be exercised or done by the TRUST in General Meeting and subject to any limitations laid down by Resolution of a General Meeting.

c) The Board of Trustees shall have all such power and shall perform all such functions as are necessary or proper for the achievement and for the furtherance of the objects of the Trust.

d) Without prejudice to the generality of the foregoing provisions, the Board of Trustees shall have the following rights and powers:

i) to acquire by gift, purchase, exchange, lease or otherwise land, building, or other immovable property together with all rights appertaining thereto.

- ii) to construct and maintain buildings, including the right to alter or improve them, and to equip and furnish them suitably.
- iii) to manage all properties of the Trust.
- iv) to prepare and sanction budget estimate and sanction expenditure of the TRUST.
- v) To accept donations or grants whether in cash or kind including property and share contributions, subscriptions and endowments on such terms and subjects to such conditions as the Board of Governors any thing proper.
- vi) To establish and collect funds and accept donations in cash or kind and to utilize the income there from for the purpose of the Trust.
- vii) To pay all expenses incurred in carrying out the activities of the TRUST.
- viii) To raise funds for the TRUST by contributions, gifts, donations or interest free loans or otherwise.
- ix) To borrow or raise any money that may be required by the Trust upon such terms any may be deemed advisable and in particular by the issue of bonds, debentures, bills of the TRUST or by mortgage or of the TRUST.
- x) To borrow or raise any money that may be required by the TRUST upon such terms as may be decided by the Boards of Trustees, from any bank, financial institutions or any other financial agency for the purpose of land and construction of building thereon or for any other asset/purpose of the Trust and to mortgage such land, building and other asset with the said bank, financial institutions or any other agency, for the purpose of borrowing money from them.
- xi) To receive monies, securities, instruments and/or any other movable property and to give receipt therefore on behalf of the Trust.
- xii) To set up, constitute and organize local branches of the Trust in such a manner and on such terms as may be considered necessary in the interest of the Trust.
- xiii) To constitute Committee(s) consisting of two or more persons, not necessarily members of the Trust and vary the same and delegate such powers as may be considered necessary for the purpose.
- xiv) To sue, defend, compound, settle, appeal or abandon all legal proceedings on behalf of or against the Trust.
- xv) To refer any claims or demands by or against the Trust to arbitration.
- xvi) To grant receipts, to sign and execute instruments and to endorse or discount cheques or other negotiable instruments through its accredited agents.
- xvii) To make sign and execute all such documents, and instruments as may be necessary or proper for carrying on the management of the property of affairs of the TRUST and to draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange and other negotiable instruments.
- xviii) To provide for compliance with the terms and conditions, attached to the repayment of loans.

xxi) To purchase or take by way of lease, sublease, right, exchange, hire etc. or otherwise acquire any movable or immovable property, and in particular any land, building, workshop-s, laboratories, machinery, equipment, furniture, library, plants, apparatus, appliances, any right or privileges necessary or convenient for the purposes of the TRUST and to construct, erect, alter, improve and maintain any buildings and to manage, develop, sell, demise, let mortgage, dispose of, turn to account or otherwise deal with all or any part of the assets and rights of the TRUST for cash or any other consideration with a view to promoting the objects of the TRUST.

xxii) To manage, sell, transfer, lease, license or otherwise dispose of any property, movable or immovable of the TRUST.

xxiii) To assign from time to time, such functions and duties and delegate or sub-delegate such powers, as it may deem fit, to any person or persons, or panel of experts or sub-committees and to reimburse such person or persons of members of the sub-committee, their travel expenses and other out of pocket expenses incurred by them in the performance of their duties.

xxiv) To prescribe the powers, functions and duties of the officers of the TRUST.

xxv) To perform all such acts and do all such things as may be necessary for the proper management of the properties and the affairs of the TRUST.

xxvi) To make by laws for the proper exercise of the powers and functions given in these Rules and submit the same to the General meeting for approval.

xxvii) To determine membership subscription from time to time.

xxviii) To call for funding payments from founder Members in accordance with the Rules.

xix) To create post, to appoint, and at its discretion, remove or suspend Scientific or administrative officers, engineers, clerks, servants and other employees of the TRUST and from time to time to determine their terms and tenure of appointment, powers and duties and determine their salaries or emoluments, allowances, rules of discipline and conduct and other conditions of service including welfare of the officers and staff of the TRUST.

xxx) To make recommendations to the Chairman for additions, variations, amendments, or repeal the Rules and Regulations of the Trust Deed.

xxxi) To call for payments from Trustees in lieu of Royalties or charges as agreed to from time to time.

xxxii) To obtain and register patents, and copyrights for work completed by the TRUST and fix royalties and other terms and conditions for their use.

xxxiii) To dissolve and wind up the TRUST in accordance with the Rules if so directed by the Trustees.

xxxiv) To delegate such administrative, financial or other powers any may be considered necessary to any Committee, individual or other authority of the TRUST and to authorize delegation of such powers and to further sub delegate.
